The Principal Researcher is Charlotte George, who is attached to the Radcliffe Department of Medicine at the University of Oxford. This research is being completed under the supervision of Professor David Sims, and in collaboration with HDRUK the University of Dundee and the CRUK Data Science Community Support Unit.

If you agree to take part, we will ask you questions about your experiences working in biomedical research with a focus on career development and collaborative working. This should take about 15-20 minutes, no background knowledge is required. We are interested in your experiences of collaborative research and career development opportunities in biomedical research so that we can provide evidence to research institutions and funding bodies to support good practice across the UK. Any data you share will be securely stored on OneDrive according to University of Oxford data protection guidelines and personal data will be handled in full compliance with GDPR regulations. Non-identifiable results from the research will be published in an open-access report, on our website ([integrate-bio.org](http://integrate-bio.org)) and shared with Research Funders and Research Institutes to enable the acceleration in adoption of good practice in career development and progression for biomedical data scientists.

### ***How will my data be used?***

Your answers in this survey will be completely anonymised. Where information we collect could identify you (e.g. specific career details) this will be removed from the data set. We will collect demographic data (e.g. age, gender, ethnicity, caring responsibilities) to access representation of different demographics within the responses. Contact details (i.e. email address) will be collected at the end of the survey via a separate consent process. Your IP address will not be stored<sup>1</sup>. We will take all reasonable measures to ensure that data remain confidential. In some circumstances quotes from responses might be used, however these will be attributed to anonymous respondents.

The responses you provide will be stored in a password-protected electronic file on University of Oxford secure servers and may be used in academic publications, presentations, reports for funders and research organisations and project website. Identifiable information will be deleted as soon as it is no longer required for the research. All identifiable data will be deleted by project end with the exception of consent records which will be held securely until 3 years after project end [31<sup>st</sup> Dec 2029]. Research data will be stored for 3 years after publication or public release of the work of the research.

### ***Who will have access to my data?***

The University of Oxford is the data controller with respect to your personal data and, as such, will determine how your personal data is used in the research. The University will process your personal data for the purpose of the research outlined above. Research is a task that we perform in the public interest.
